### Moozz Music Contest Terms and Conditions

**1. Introduction:** Welcome to the Moozz Music Contest! These Terms and Conditions govern your participation in the contest hosted by Muzico Innovations GmbH for music producers. By participating in the contest, you agree to comply with these terms. Please read them carefully.

**2. Contest Overview:** The Moozz Music Contest provides an opportunity for music producers worldwide to contribute to the development of the Moozz music app. Participants stand a chance to win prizes and potentially earn royalties once the app is monetized. The contest duration spans from February 15th to April 18th, 2024.

**3. Participation Requirements:** To participate, music producers must:

- Follow @moozz\_official on Instagram.
- Register at <https://dashboard.moozz.com/admin/register?contest>.
- Watch the tutorial provided by Moozz.
- Create and upload original content that adheres to Moozz's technical requirements and guidelines.

**4. Music Genres Allowed:** EDM, Hip-hop/Trap, and Reggaeton.

**5. Submission Rules:**

- Submitted content must be original and should not infringe upon any third-party rights, including copyright.
- Participants can upload multiple stems to enhance their chances of winning.
- Moozz reserves the right to disqualify any submission that violates these rules.

**6. Prize Details:**

1st Place: Ableton Suite 12 license, KRK RP5 Rokit 5 G4 Professional monitors, Audio Technica ATH-M50X headphones, 2 Native Instruments Play Series VSTs, or equivalent cash prize of \$1,486.08 USD.

2nd Place: Ableton Live 12 license, Focusrite Scarlett 2i2 4th Generation Interface, Audio Technica ATH-M50X Headphones, or equivalent cash prize of \$863.42 USD.

3rd Place: AKG Pro Audio K245 headphones, 2 Native Instruments Play Series VSTs, or equivalent cash prize of \$219.33 USD.

### **7. Jury and Selection Process:**

- Moozz's team will shortlist melodies, which will then be voted on by an independent panel.
- Winners will be announced on Instagram.

### **8. Stem Requirements:**

- Participants must adhere to Moozz's specified BPM, musical key, required instruments, and style.
- Stem length and structure must meet guidelines outlined in the Artist Area documentation

**9. Intellectual Property Rights:** By participating, participants grant Moozz exclusive rights to use, modify, and distribute their content for promotional and commercial purposes. Participants acknowledge Moozz's ownership of the content and waive intellectual property and moral claims. **Participants are entitled to royalties once the app monetizes its model**

**10. Automatic Access to Beta App:** Participants gain early access to the app and all provided stems from producers worldwide. **Note:** The app is under development and will be available for beta testing in the coming months.

**11. Legal Agreement:** Participants grant Moozz exclusive rights to use their submitted works. The agreement lasts for 5 years, with automatic extensions unless otherwise agreed upon.

**12. Agreement:** By participating in the Moozz Music Contest, you agree to abide by these terms and conditions. Failure to comply with these terms may result in disqualification from the contest.

**13. Dispute Resolution:** Any disputes arising from or in connection with the contest will be resolved through arbitration in accordance with the laws of Switzerland. The arbitration proceedings will take place in Zurich, and the language of arbitration will be English.
